- Schizophrenia, etc.

Observations and Impact:

- We are getting a **good response from college students** and parents from schools are enquiring to avail the services.
- The overall **feedback** on various webinars was positive.
- The **follow-up** sessions are going well and the student's feedback regarding the services at Mpower was also good.
- As per the need, creatives are being shared fortnightly to promote the cell.



Challenges:

- Rescheduling the sessions from the student's end.
- Less participation of teachers in webinars.

Recommendations:

- As the therapist always orient students to be consistent in attending scheduled counseling sessions so the faculties can also orient students on the same. So, we can give the slot to the new or waiting students.
- Convey the students to reduce the rescheduling of counselling sessions.
- As we have least referrals from the schools, we would like to request that teachers and counselors can be more proactive and refer students or convey parents to avail the session from Mpower.
- The college POC can convey teachers to attend the webinar as it's planned well in advance or make it compulsory so we can reach the maximum students.
- Awaiting revert from Century Rayon POC to generate more referrals.

Other updates:

- Seminars are planned for all the units in the coming month and the calendar has been circulated.
- The **regular review meetings** with the POC's are going well and have been recorded.
- The follow-up of sharing the **creatives** were recorded.
- The **offline** sessions were started as per the students need and for the same **parent's consents** were also collected as the college POC suggested.
